

### SUBMISSION GUIDELINES

First page of the book chapter should contain only the title of the book chapter, names, designation and institution name. It should not contain any other contact information / postal address (e-mail ids and phone numbers (including mobile numbers)) of authors / co-authors. Moreover, each research contribution has to be provided with a declaration by the lead and / or corresponding author after official acceptance of your book chapter (s).

- 1) The Title of the Paper should be bold in Times New Roman with Font Size 14.
- 2) The book chapter should be in Single Line Spacing in Times
  New Roman with Font Size 12 throughout the entire paper
  including all the Captions (bold) and Sub-Captions (bold).
- 3) Abstract not exceeding 150 -200 words with a maximum of 6 key words.
- 4) The word limit for book chapter is between 2500 6000 words.
- 5) One-inch margin to be maintained on all sides (Top, Bottom, Left & Right) of the book chapter document.
- 6) The book chapter should be prepared in accordance with a definite research methodology and comprise of suggestions and conclusions.
- 7) References cited should be Minimum 10 and Maximum 20.
- 8) The references whichever mentioned in the text body have to properly listed under the reference section. The authors are advised to avoid incomplete referencing and foot notes.
- 9) The references should be in American Psychological Association (APA) format for book chapters falling under the streams like management / arts / social sciences / humanities) and IEEE format for book chapters falling under the streams like sciences (including medical and paramedical sciences), engineering and technology duly cited (in case of APA formatting) and numbered (in case of IEEE formatting) accordingly within the text body of the chapter.
- 10) All the Tables to be legible and properly justified.
- 11) All the Pictures and Figures should be in JPEG format.
- 12) Author(s) must ensure the provision of non-plagiarized content of their respective book chapter, wherein the maximum plagiarism acceptance (references (including author's self-referencing) and corresponding text citations) rate for this edited book is only 15%.
- 13) Plagiarism Report to be submitted along with the Article.
- 14) The Lead Author and / or Corresponding Author (in case of joint research book chapter) need to sign a copyright form after final acceptance of the book chapter.
