



i-manager Publications - Submission Guidelines

Publishing Partner (Journal Publication) for International Conference on Contemporary Researches in Engineering, Science, Management & Arts (ICCRESMA '2024) scheduled on 22 – 24 February 2024, created and powered by Centre for Research & Training (CRT), National Foundation for Entrepreneurship Development (NFED), Coimbatore, Tamil Nadu

The author must provide:

- his / her name
- his / her job title
- his / her organization/institution of affiliation name, address, Handphone & WhatsApp number
- a brief biographical description
- a photograph in JPEG format

In the case of more than one author, the corresponding authors' full details including email, fax, phone, and address for communication need to be provided.

The maximum no. of authors per article is Four.

In addition:

- The paper needs to contain a title, an abstract, keywords, main body with sections and subsections, discussion, conclusion, and references in **single line spacing**.
- All references need to be cited completely.
- APA format should be followed for referencing and citation.
- Font style: Arial in 10 pt size.
- Word Limit is 2500 5000 Words.
- Figures and tables should follow the references. Make sure that every table or figure is referred to in the text. The table or figure will be placed after the first mention in the
- Illustrations, if provided, should be clear and in JPEG format.
- All articles should be error free to the maximum extent possible and any technical matter must be as clearas possible.
- Plagiarism should be limited to 15 percent.
- All authors should sign the copyright form.

Author Responsibilities

Authors should ensure that they have written and submitted only original works, and if they have used the work and/or words of others, that has been appropriately cited.

Plagiarism in all its forms constitutes unethical publishing behaviour, which is unacceptable.

Authors should not submit for consideration a manuscript that has already been published in another Journal.

Submission of a manuscript concurrently to more than one Journal is unethical publishing behaviour and unacceptable.

Submission Procedure

Authors should submit the full paper / article complying the aforesaid journal submission guidelines to conference.nfed@gmail.com for initial screening and / or scrutiny thereby facilitating the further processing through placing its recommendations and forwarding the same to publishing partner (i-manager publications) for journal publication.

From thereon, all the communications from review process till publication decision is at the discretion of publisher (i-manager publications).

Review Procedure

All papers received from NFED's ICCRESMA 2024 conference will be sent to i-manager publications for double blind review process.

The final selection of the papers would be based on the report of the review panel members and approval of the Editor-in-Chief of concerned journal under i-manager publications.

The article shall be published within a period of **75-90 days**.

Copyright

Upon receiving article from NFED, author(s) will be contacted by **i-manager Publications** and will be requested to complete the copyright form, which transfers copyright in all original material in the article to the publisher if the article is accepted.

The copyright form must be filled in correctly, signed, dated, and submitted before an article can be accepted.

i-manager Publications holds the Copyright of the article to be published/published and any content to be re-used by the author(s) will require the official consent from the Publishing Partner / Publisher (i-manager publications).
